Subject: Re-numbering of Section 12-A of the Principal UGC Act
1956 as Section 12-B w.e.f 1st October, 1984-regarding.

Sir,

I am directed to say that the University Grants Commission
(Amendment) Act, 1984 has come into force w.e.f 1st October, 1984
vide notification No.F.12-7/84-Desk-U dated 1st October, 1984
issued by the Ministry of Education & Culture, Govt. of India,
published in the Gazette of India, Extraordinary (part II,
Section 3-Sub-Section (ii)). Section 3 of the UGC (Amendment)
Act, 1984 provides that in the principal Act of 1956, Section
12-A is to be renumbered as Section 12-B. The effect of the
UGC (Amendment) Act, 1984 would be that w.e.f 1st October, 1984
Section 12-A of the Principal UGC Act, 1956 would read as Section
12-B which would include the rules previously made under this
Section.

This modification is brought to the notice of the Univer-
sity for information and appropriate action.

It is requested that this may be brought to the notice of
all the Colleges/institutions within the jurisdiction of your
University.

The UGC Act, 1956 (as modified upto 1st October, 1984) is
being printed. A copy of the UGC Act, 1956 will be made available
to the University in due course.
